Seal an opening in the foundation wall of Bldg. 225, on the south side of the building, approximately 10 feet from the southwest corner. The opening has been cut to extend a pipe (existing) through the wall.

The opening must be sealed because it permits escape of chemical-laden industrial wastewater to the alley south of Bldg. 225 and subsequently to storm drainage--a violation of Federal and California law.

(The underfloor area of Bldg. 225 serves as a wastewater collection area. When the wastewater level rises, the wastewater flows through the subject opening.)
